

Contract Rider - Max Judo

*updated Jan 2008

All deletions or revisions to this contract rider and/or the provisions for Max Judo must be indicated, initialed and dated by both parties at least 2 weeks prior to the engagement. If the time span is not applicable Max Judo must be notified verbally of any changes to the contract.

Venue: The venue should be available to Max Judo at least 2 hours prior to the scheduled time of performance. If venue is not available that far in advance, simply clarify with Artist or Agency at least 1 week prior to show so we can discuss proper set up and load in times. Max Judo will notify venue of exact loading/check times. All staging and production should be complete upon Max Judo load in time.

Loaders: The venue should provide two (2) loaders during load in and load out to assist in carrying equipment.

Parking: Purchaser must provide free or pre-paid parking for a 15 passenger van with trailer which should be close and accessible from the entrance & load area of the venue. Max Judo is not responsible for fines/fees resulting from parking in an illegal area.

Sound Check: Max Judo requires at least one (1) hour closed sound check (unless show is in an open-all-the-time area) after the band & sound company is properly set up. Buyer agrees to keep non-venue employees out of the venue during sound check.

Lodging: Two (2) non-smoking hotel rooms in a clean and reputable 3 star hotel or equivalent. Each room must contain two (2) beds. If possible, the rooms should be adjacent to each other.

Staging: A minimum stage of 20' x 10' x 2.5'. If performance is outdoors proper indoor facilities are necessary for backup plans.

Minimum Sound and Lighting Requirements (when applicable).

Lighting: A minimum of Four (4) PAR 56 light cans on each side of the stage with colored gels

Sound: One (1) mixing console-minimum 16 channels. One (1) sub (18") on each side and one (1) mid range/high pack (15" and horn) on each side.

Basic system requirements are:

- * Full PA system *(full PA includes but is not limited to mixing console for main and monitor mixes; power amplifiers; main speakers; monitor speakers; microphones for vocals, instruments and amps; mic stands; all of the necessary cables)
- * Stage access to electrical outlets
- * Drum kit mics (minimum kick, snare, and overheads; preferably more)
- * 2 SM-57 or comparable guitar mics
- * 1 bass guitar DI
- * 1 acoustic guitar DI
- * 1 didgeridoo mic
- * 3 SM-58 or comparable vocal mics
- * 4 mix monitor system preferred

Engineer: A qualified engineer or equivalent must have sound system set up in time for sound check, remain for the duration of performance and dismantle sound system after performance.

Dressing Room: The dressing room must be a lockable room that has a suitable restroom nearby. Only Max Judo, crew, venue employees and allowed guests will have access to this room. If there is no dressing room available, Max Judo should be notified of accommodations.

Support: There will be no support added of any sort without the consent of Max Judo.

Other Entertainment: No T.V. screens, radios, CD players or jukeboxes of any kind shall be in use during Artists performance.

Cancellation: Artist reserves the right to cancel or postpone this engagement up to thirty (30) days prior to performance. We do not cancel gigs without a valid reason. Artist will not be held responsible for cancellation of this engagement at any stage due to the detention or prevention by major national tour, television appearance, radio event sickness, inability to perform, accident, means of transportation, acts of higher beings, riots, strikes and all other events out of the Artists control.

Guests: Max Judo will be allowed ten (10) guests, not including family members of the band, plus five (5) press list spots free admission to the venue.

Merchandise: Buyer shall provide a table and chair in a well-lit, high traffic area within the venue. Artist shall sell own merchandise and requires that they retain 100% of all sales.

Taping & photography/Reproduction of performance: Max Judo does not allow visual or audio taping of their show without prior consent of the band. In such cases, artist shall not permit reproduction or rebroadcast of any performance without the express written consent of Artist.

Hospitality:

- One case of bottled water.
- Tea with lemon and honey
- Fresh towels
- Six meals to be provided with beverages, Pizza is fine or food buyout of \$15 per person also acceptable in lieu of the seven meals
