

Contract Rider - The Ballroom Thieves

THE BALLROOM THIEVES

1. Tech Needs- PURCHASER will provide:

- * Two (2) Direct Input Boxes.
- * Three (3) Vocal microphones (Shure SM58 or similar quality).
- * Three (3) Instrument microphones (Shure SM57 or similar quality).
- * Seven (7) Boom Microphone Stands (Two can be low-profile stands).
- * Ten (10) XLR cables for microphones (appropriate length).
- * One (1) PA System with at least 1000 W capacity.
- * One (1) Mixer with ten (10) inputs (only 8 for small coffeehouse style settings) and any and all appropriate cables.
- * Two (2) On-Stage Monitors with all appropriate cables.

2. Front of House- PURCHASER will provide:

- * One (1) qualified sound person at no cost to performer, consisting of at least these minimum requirements:
- * One (1) mixing console-minimum 16 channels.
- * One (1) sub (18") on each side and one (1) mid range/high pack (15" and horn) on each side.
- *Speakers should if possible be EAW or JBL.

(Performers will be unable to mix their own front-of-house sound while performing.)

3. Parking- PURCHASER will provide:

- * Free or pre-paid safe parking near venue for artist's vehicle, which should be close and accessible from the entrance & load area of the venue. The Ballroom Thieves is not responsible for fines/fees resulting from parking in an illegal area. If possible, please have one (1) loader available to help with load-in and load-out of equipment.

4. Dressing Room- PURCHASER will provide:

- * One (1) room for the sole purpose of The Ballroom Thieves lounging, resting, and eating. This lockable room should be clean, smoke-free, comfortable and have seating facilities (such as couches, upholstered chairs, etc.) for four (4) people. Ideally, this room should also contain one (1) full-length mirror.

5. Merchandise- PURCHASER will provide:

- * One (1) table and one (1) chair in a well-lit, high-traffic area within venue for band to sell merchandise.

6. Catering- PURCHASER will provide:

- * One (1) case of bottled water (at least ten (10) bottles).
- * Six (6) Fruit Smoothies (Odwalla, Naked, or equivalent brand).
- * One (1) Bag of Nuts or Trail Mix (Choose your favorite brand).
- * Hot water and Tea (and honey, if possible).
- * Four (4) meals with beverages, or \$15 food buyout per band member.

7. Hotel Accommodations: If required on the first page of this contract (section 5a.), PURCHASER to supply two (2) double rooms (2 beds) in a national hotel chain. If no appropriate accommodations are available a \$100.00/per room hotel allowance will be added to the agreed price. This rider is hereby attached and agreed to by:
